The role of IFRS's Other Comprehensive Income during the financial crisis Kenneth Born, 2017-01-09 The broad consensus before the recent financial crisis was that the so called fair value accounting FVA improves transparency contrary to the historical cost model Since 2008 the discussion has been on the root cause of the crisis which lessons can be
