ST-segment elevation myocardial infarction and blocked coronary artery confirmed via angiography.	Decreased cardiac output related to tissue damage on the heart wall and a blocked coronary artery decreasing blood flow to the heart as evidenced by the results of the patient's angiography and electrogram.	*Prepare the patient for percutaneous transluminal coronary angioplasty, currently ordered, as soon as possible due to the 60-minute critical time frame. *Reduce the patient's pain level. *Rule out dissecting aorta. *Order immediate labs needed for the patient's procedure. *Prepare the intensive care unit to receive the patient after the procedure.	*Order potassium and creatinine labs immediately to assess baseline levels and monitor them after the procedure has taken place for changes. *Order Troponin labs to assess for myocardial damage. *Order a bedside chest x-ray immediately to rule out a dissecting aorta, if present inform the provider immediately. *Administer 4mg of morphine intravenously for pain relief and vasodilation. *Obtain baseline vital signs and reassess them at least every 5 minutes until the patient is stable after the procedure.	*The procedure went well and a stent was placed in the left descending coronary artery. *The patient's vital signs are stable and there is no bleeding or hematoma.
