,2004 In the 17th century physicians in China blew powdered smallpox scabs into sinuses and prepared pills made from the fleas of cows In India physicians applied scabs to the scarified skin of the healthy This technique migrated westward to Turkey where it was discovered by western physicians Other early attempts to control smallpox included inoculation with material from smallpox lesions This practice was known as variolation In 1796 Edward Jenner noted that milkmaids were free of the facial scars that marked most of the population of that time The observation that they cannot take smallpox was attributed to the localized pox lesions that they developed in their hands Jenner reasoned that infectious material from cowpox caused by the vaccinia virus lesions provided protection from smallpox caused by the variola virus He used it to vaccinate an 8 year old boy The boy later resisted infection demonstrating the efficacy of the first vaccine **TEXT BOOK**
