Relationship between Remand and bail

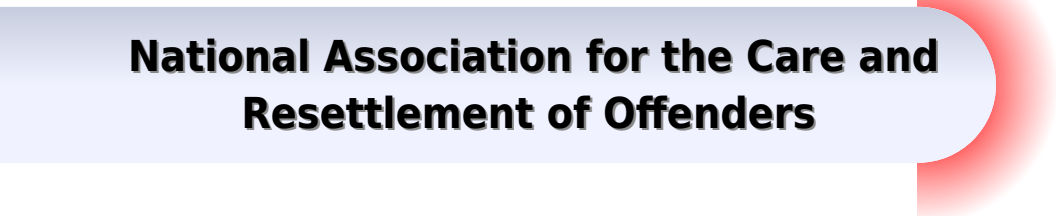
- Remand and bail constitute distinct though related inquiries
 - Practitioners often make the mistake of either equating a remand enquiry with a bail inquiry Or
 - Substituting a bail inquiry for a remand inquiry
- A remand enquiry must precede a bail inquiry, bail will enquiry takes place only after propriety of remand is established
- Placement on remand must be challenged and appealed otherwise the placement stands *S v Maguwu* [FARI MAGUWU \(jsc.org.zw\)](https://www.jsc.org.zw/cases/FARI%20MAGUWU).
- If placement on remand is not challenged on first appearance, it cannot be raised for the first time in a bail appeal *Ching'ono v State* HH519/20
