Antler New York just heard the pitches for pre-seed investment delivered in front of the investment committee by Sleuth and Marco Financial. Both teams exhibited unique combinations of quantitative and qualitative factors and different approaches to building a company. The Antler team was looking through all the insights from their time working with the entrepreneurs, and the startups they formed, over the last three months, to make the investment decisions. Beyond the current decision, Magnus Grimeland and Fridtjof Berge, Antler's founders, were wondering how the increasing amounts of data that were being generated about entrepreneurs and their interactions on the Antler platform could be used to improve the selection process for its programs and, for those founders selected to participate, predict their probability of future success.

Antler was a global early-stage venture capital firm founded in 2017 by Magnus Grimeland (CEO & Co-founder, Harvard College 2007) and Fridtjof Berge (COO & Co-founder, HBS 2016) to invest in exceptional people who were building technology startups from the pre-seed stage onwards. In doing so, Antler aimed to solve several market inefficiencies they felt were systemic in startup ecosystems. In their view, these included lack of access to pre-seed funding, great co-founders, and a strong support network. "In many ecosystems, by the time the institutional capital came in, the founders had already spent at least six months or a year building the team and validating the problem and solution
