

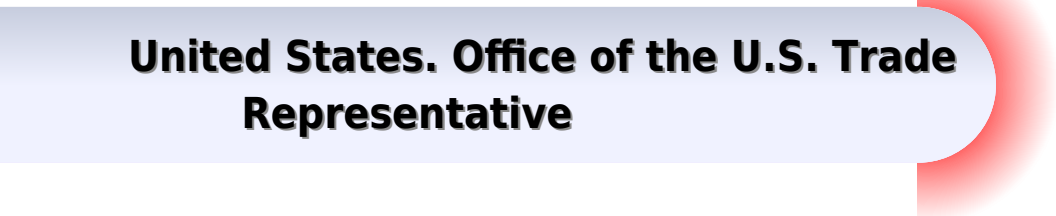
What Is Competition Advocacy?
