- Majority of PI and CN cases are concluded this way.

Actively encouraged by pre-action protocols:

- Pre-Action Protocol for the Resolution of Clinical Disputes Para 5.
- Pre-Action Protocol for Personal Injury Claims Para 9.

CPRs actively encourage ADR as a means to aid prompt settlement.

- CPR 1.4(2)(e): the court is to: *"encouraging the parties to use an alternative dispute resolution procedure if the court considers that appropriate and facilitating the use of such procedure"*.

MOUNTING PRESSURE TO USE ADR

- CPR 44.4— Costs sanctions for non-compliance.
- Case management conferences and PTR- parties will be asked to confirm whether ADR has been considered, and if not why not.
- “Ungley” orders in CN- Ungley orders requires the parties to consider ADR before trial, and to file with the court their reasons for objections to mediate, and which can be considered in relation to costs after judgment.
- Clinical Disputes Forum guidance.

ADR AND CASE LAW

- Cowl v Plymouth City Council 2001
 - “Today sufficient information should be known about ADR to make the failure to adopt it, in particular when public money is involved, indefensible.”
- Dunnett v Railtrack 2002
 - Parties were asked to “explore” the possibility of ADR
 - Any party who “turned down flat” ADR would have to face “uncomfortable cost consequences”.
