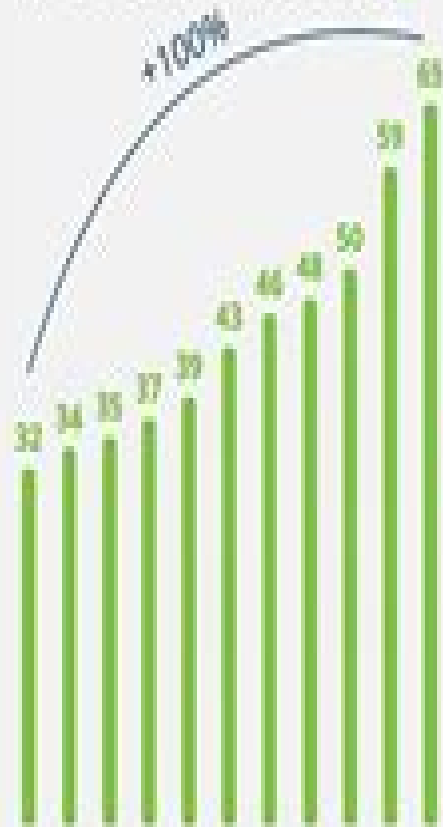


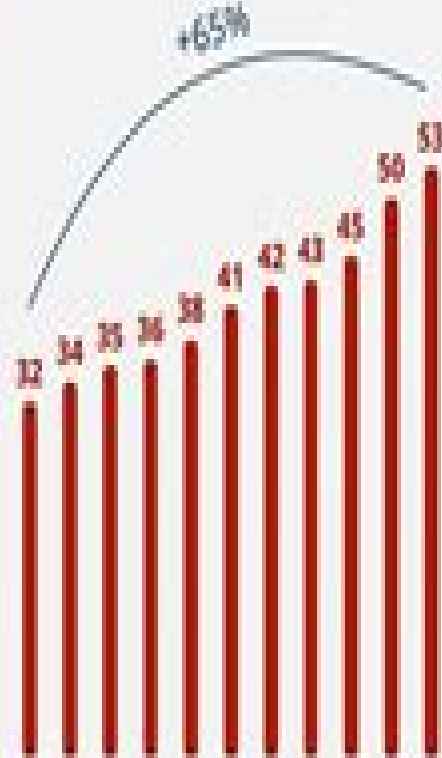

Worldwide, gross revenue in \$ billion (2013 to 2023)

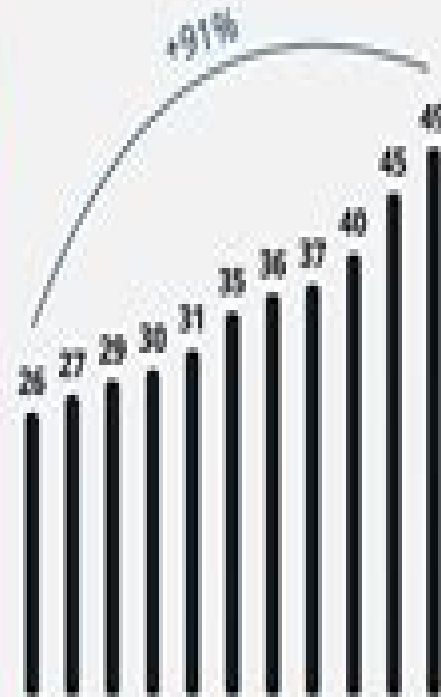

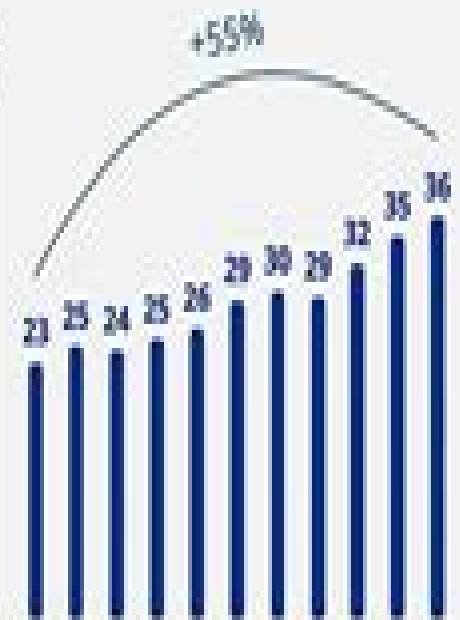
